Subject:- Major action points identified during the conferences of Vice Chancellors of CUs held during 2018.

Sir/Madam,

The President's Secretariat has conveyed the following major actionable points identified during the conferences of Vice Chancellors of Central Universities (CUs) held during 2018:-

- (i) All Central Universities should formulate, regularize and strictly adhere to their Academic Calendar, covering all aspects such as admissions, examinations, declaration of results and awarding of degrees at convocation.
- (ii) All CUs should ensure regular attendance by teachers as well as enforce financial discipline and maintenance of accounts. Where possible, they may bring in officers from the Central Services as Registrars and Financial Officers to ensure certain standards.
- (iii) Faculty vacancies in CUs should be filled quickly and urgently. Anticipated vacancies should be planned for months in advance. Efforts should be made to attract and recruit quality faculty from abroad.
- (iv) CUs have to contribute to the well-being of the community and the state that hosts them and it should be their moral responsibility to enhance opportunities for talented children in the backward regions.
- (v) CUs should equally concentrate on research. Efforts should be made to enhance NIRF ranking.
- (vi) It must be ensured that Convocations are held regularly and on time.
- (vii) All the institution should work for increasing their internal resource generation by taking following steps:
 - Alumni Cell to be set up in each Institute. Wherever such cells are already set up, they may be reviewed and re-strengthened and efforts should be made to involve them in contributing their Alma Mater better.
 - Development of prototypes and commercialization of Patents and IPRs.
 - Mobilizing funds through industry collaborations.

2. It is requested that appropriate action may be taken on the above issues and an action taken report be submitted to this Department latest by 27.9.2018.
