11.	Research Proposal (hard Copy as well as P.P.T.)

- Candidates who fail to report within the scheduled time limit shall lose their claim for admission.
- Documents required (in original and one set of self-attested Photo copies) for taking.
- Mode of payment of admission Fees through **Demand Draft/Cash only**. No other mode will be accepted.
- If a candidate fails to produce any of the above mentioned documents required for admission she/he may not be admitted.
- No separate information will be sent to the selected candidates. The candidates are therefore advised to find out their result from the Department Notice Board or the University website (www.bbau.ac.in) and attend counseling personally for admission on the specific dates and time. Failure to do so will be the sole responsibility of the candidates and their claim for admission will cease.**
- It may be noted that admission in all the programs is subject to verification of documents and understanding that you have already verified your eligibility and declaration given by you in the Entrance exam application form.
- All certificates must be issued by competent authority in appropriate format.
- Hostel may be made available to students based on criteria decided by the BBAU, for which they have to make separate application to DSW on format available on University website. Only limited accommodation is available in hostel.
