Terms and Conditions

Annexure -I

1. The minimum turnover of the Suppliers/Publishers should be at least Rs. 1 (one) crore per annum during the last two years.
2. The Suppliers/Publishers should have a valid certificate of the Federation of Publishers' and Book Sellers' Associations in India.
3. The Suppliers/Publishers should a Tax Payer from last two year.
4. The participant vendors, publishers will have to give a minimum of 21% discount on Paper Back Volume and 23% of discount on Hard Bound Volumes. There may be no discount on Govt. Publications. However, each title will be negotiated by the concerned to avail maximum discount in the interest of the university.
5. In case of foreign publications, the rate of conversion of foreign currencies to Indian currency shall be according to GOC rate on date of issue of purchase order.
6. The cost of transport shall be borne by supplier.
7. In case of foreign edition a certificate would be required stating that Indian reprint/edition is not published.
8. The supplier has to produce the publisher's catalogue/invoice of the publishers for verification of the cost of the books.
9. Preferences will be given to the latest publications (Published after 2012) and Paper bound volumes.
10. The suppliers are expected to bring the books covering the subjects/courses running by the University. The detail of same is available on our website www.bbau.ac.in
11. The University (BBAU) reserves the right to accept or reject any or all items of the proposals at any stage without assigning any reason. Decision of the University on any dispute related to 'Book Exhibition' shall be final and binding.
12. In the case of any disputes or misunderstanding arising out of this agreement, the decision of the University shall be the final and binding to the supplier/Publishers.
13. The Registration Fee of **Rs. 7500/-** should be made in the form of Demand Draft in favor of the **Finance Officer, Babasaheb Bhimrao Ambedkar University** Payable at Lucknow .
