**1) Eligibility Criteria:**

- a. The firm should be registered in electrical category from BBAU /CPWD /PWD /MES /Central PSU /State PSU and should be at least 3 years old in respect of electrical works of similar nature
- b. The firm should have successfully carried out similar works in Central Government/State Government/Central or State Autonomous Bodies/Central or State Public Sector Undertakings during the last three years as following
  - i. Three similar completed works each costing not less than the amount equal to 30% of the estimated cost  
OR
  - ii. Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.  
OR
  - iii. One similar completed work of aggregate cost not less than the amount equal to 80% of the estimated cost.
- c. Average Annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be at least 50% of the estimated cost.
- d. The firm should have valid Registration Certificate in Electrical Category from CPWD/PWD/ Central PSU/State PSU.

- a. Supply / Works shall be carried out as per B.O.Q./C.P.W.D. specifications
- b. All the materials required for completion of work shall conform to latest ISI/CPWD specifications
- c. All the warranty cards/ certificates of electrical items shall be provided to University for any further assistance.
- d. Contractor shall not make any additional claim in rates for the variation in quantities, if any.
- e. The rates quoted by the contractor include the rates for all materials, cartages, taxes etc. required for proper completion of work.
- f. The authorized representative /committee of the University will accept or reject the work executed, according to the laid down norms of CPWD. The contractor is also required to modify the work suitably, as may be suggested if the work done already is not upto the proper specification.
- g. In the event of any, dispute and/or differences, whatsoever arising under this order, the decision of the Vice-Chancellor, Babasaheb Bhimrao Ambedkar University shall be final and binding on the contractor.
- h. The court of competent jurisdiction will be Lucknow only if any dispute arises.
- i. All work executed shall be paid according to the measurements taken by or under the orders of the University and not according to the quantity given in any estimates.
- j. Payment shall be released after completion of the work to the satisfaction of Engineer-in-charge.
- k. The work should be completed within 30 days from the issue of work order.
- l. Income tax or any other tax shall be deducted as per Rules of Government of India/ State Government. Contractor shall be required to produce PAN number at the time of release of payment.
- m. 10% security deposit shall be deducted from the bill of contractor which shall not be refunded before the expiry of 12 months after issue of certificate for final completion of work or till the final bill has been prepared and passed whichever is later
