LL.M. Final Semester Examination for session Jan-June 2020 Regular & Back Paper

In pursuance of the UGC Revised Guidelines on Examinations and Academic Calendar for the Universities in view of COVID-19 Pandemic the dated 06/07/2020 and notification of the University letter No. Comp-1/COE/BBAU/2020 dated 07/07/2020 all the 4th Semester students of LL.M. course are hereby directed to submit their dissertation/ project in soft copy (PDF form) on email id: llmendterm2020covid19@gmail.com on or before August 21th, 2020.


The viva- voce examination of LL.M. course shall be conducted August 24th, 2020 through online mode. The login and password for the viva will be given to the students on WhatsApp 1 days in advance. Time table of examination annexed as annexure-I

Students are need not to approach to the department Physically.

The mode of the Examination, Question Paper Pattern and Timing will be as follows:

- i. The written papers (Regular/Back Papers) will be of two hours instead of three hours. All the written papers will be of grades equivalent to 70 marks.
- ii. There will be 3 parts of the paper. Part A will be compulsory and will contain 5 questions of 5 marks each total 25 marks for which the students will write approximately 50 word answers. Part B will contain 5 short note questions out of which the students will attempt any 3 questions of 10 marks each, total 30 marks for which the students will write approximately 100 words each. Part C will contain 3 long answer questions out of which the students will attempt any 1 long answer question of 15 marks of not less than 500 words.
- iii. The students will mark their attendance on the Whatsapp group of concern subject teacher 15 mins prior to the exam time. Thereafter, exam paper will be circulated amongst the students 5 mins prior to the examination time on the group.
- iv. The answers will be hand written on single line register sheets.
- v. After the completion of 2 hours, students will be granted an additional 15 minutes to scan and submit their answer scripts on the official examination email address.
Any answer script submitted beyond the additional 15 minutes will not be accepted as submitted.
- vi. However students who are unable to scan or submit the answer scripts on the official email are permitted to click photographs of their answer sheets and compile them into a PDF and submit on the email id: llmendterm2020covid19@gmail.com
- vii. The examinee is strictly prohibited from copying answers from any books, reference material or online sources. In case any answer script is found wherein
